MOTION: To adopt the FPCO/The Collaborative Realignment Proposal as the guiding document for the initiation of The Collaborative, to be recognized as an independent charitable corporation, under the leadership of Dr. Case Thorp. – M/P

MOTION: To appoint ruling elder and attorney Michael Kelley, in conjunction with FPCO COO Charles Bell, with the following duties:

- a) To serve as the legal representative of FPCO in incorporating The Collaborative, Inc. as a public charitable corporation, pursuant to the requirements of the Florida Secretary of State.
- b) To draft and execute an Assignment Agreement delineating the transfer of intellectual property and physical assets from FPCO, Inc. to the newly incorporated The Collaborative, Inc.
