Gifts to Organizations from FPCO

As our community struggles through this season of COVID-19, the Lord has blessed FPCO that we might be a blessing to the community. There are currently 3 different funds from which FPCO can make sizable donations to organizations in the community who are in need as they serve sections of the community.

Arise & Build: (100K)

The Arise & Build Fund allocated 10% of the entire campaign to strategic mission organizations. The three organizations included our Ministry in Mercy Drive (which is no longer in operation), our partnership in Madagascar with the FJKM, and Mission Emmanuel in the Dominican Republic. We are able to give outside of those three intenties so long as the session approves the gifts.

Mission General: (200K)

The Mission General Fund is a restricted account that is outside of the operating budget. It is restricted for the purposes of Mission work (vague).

Mission Support: (100K)

The Mission Support money comes directly from the operating budget and is awarded annually through our Mission Support Process. The normal process occurs from October to January and then, depending on how the budget is tracking, we give away a final amount in April or May. This year, due to the virus, we waited longer to see how the budget would look, come May, and so far we are tracking ahead giving us plenty of room to make some large gifts to partners.

Prioritization:

- 1. Current Partners who are Serving the Immediate Need
- 2. Who is helping the most vulnerable in the community in the current crisis? (The City)
- 3. How might generosity give us an opportunity to forge new/needed relationships within the Central FL community?
- 4. Other mission partners or missionaries.

He has done an incredible job with UP as it stands out as one of the best models for lifting people out of poverty in Orlando and even in the country. CSC is contiuning to provide food assitance to families in need and the need has grow tremendously in this season.
1	Samaritan's Village	yes - Strategic Partner	\$50,000.00	A&B - Already Paid	This gift was vooted on a month ago to provide for SV in their expansion plan to serve more women in the central Florida area.
1	Grace Medical Home	yes - Strategic Partner	\$15,000.00	MS	Grace Medical Home has continued to see patients and has received more patients due to the current crisis.
2	Polis Institute (Central Florida United)	yes	\$25,000.00	MG	Polis is a long time partner of ours and has done incredible work to pivot their time and resources to Centralfloridaunited.org This site is multicafected offering information, service connections, volunteer options for the people of central Florida. We would give this gift to Polis and direct it specifically to the CFU efforts.
2	Second Harvest Food Bank	no	\$25,000.00	MG	Second Harvest has been designated as the primary food distribution source in Central FL through COVID-19. They have received grants in various amounts and yet the need continues to grow as people are furloughed and lost jobs.

3	iDignity	yes - Strategic Partner	\$25,000.00	MS	This money would be going towards a capital campaign. We were planning on making a gift in this direction before COVID and we want to make good on our committment to their ongoing work!
3	RTS	yes	\$15,000.00	MG	RTS had its worst giving month (April) in a numner of years. They are in need of raising 1.2 million in ithe month of May to break even. This is substantial because of the number of students that recieve scholarshipsat RTS. If these scholarships are not availble, many of the students will not be able to continue in their studies at RTS. FPCO has been committed to seminary training as a part of our conviction to invest in the next generation of pastors.
3	Orlando Philharmonic - Some Sort of Arts Organization?	no	\$15,000.00	MG	The arts are very important in how we understand God's call to "be creative/productive" - a huge part of The Collaborative - and one of the places where our city is hurting the worst: no shows, performances, or opportunities. Giving to the Phil, where elder Melody Lynch is chair of the board, makes an important statement to our community about how the church views the arts.
4	Choices Women's	Yes	\$10,000.00	MS	Choices is continuing to serve the community through offering care to pregnant women in the community. They are a pro-life organization and are expanding their efforts to the UCF area with a new clinic.
4	Timothy Two Project	yes	\$5,000.00	MS	Timothy Two has missionaries all over the world with a focus on training indigenous pastors. They have had to scramble to get missionaries home/or in safer places duing this season. They have created a general fund for their missionaries with extra needs. We would be contributing to this fund.
4	Current FPCO Missionaries	Yes	\$24,000.00	MS	This gift would be an extra \$1,000.00 to each of our missionaries in our current portfolio. We have heard that some of our missionaries are losing donors and are unsure of the next season of fundraising and ministry.
